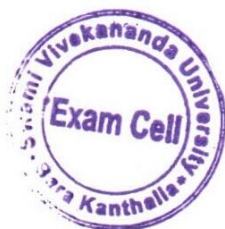
** In case the information/documents are found to be false/incorrect, the responsibility shall lie solely with the candidate and he/she shall be liable for action as to be taken by the University.
