### **It may please be noted that:-**

- 1) The University may admit students who have already qualified for fellowship/scholarship in UGC-NET/UGC-CSIR NET/GATE/CEED and similar National Level test based on an interview,
- 2) All other students having requisite eligibility criteria for admission to the Ph. D. programme and those who have already qualified for NET (without fellowship/ scholarship) must have to appear at Research Entrance Test (RET),
- 3) RET syllabus shall consist of 50% of Research methodology and 50% shall be subject specific,
- 4) The eligible students who shall secure a minimum of 50% marks in the RET are ELIGIBLE to appear at the interview/viva-voce to be conducted by the specific Department Research Committee OR an equivalent body of the University.
- 5) A weightage of 70% for the RET and 30% for the performance in the interview/viva-voce shall be given for preparation of Merit list,
- 6) The University shall decide the number of eligible students to be admitted based on the number of Ph. D. seats available.



7) Eligibility criteria for admission to the Ph. D. programme will strictly be followed as per guidelines of the UGC (Minimum Standards and Procedures for Award of Ph. D. Degree) Regulations, 2022.
