In continuation of this office notification number SVU/COE/23/18 dated 17th August, 2023 it is further notified for information of all concerned that the date of submission of examination forms of ODD SEMESTER EXAMINATIONS, 2023 of all the programme (i.e., Diploma, UG and PG of 1st, 3rd, 5th and 7th Semesters) has been extended upto 11th November, 2023 with LATE FINE OF Rs. 150/-(rupees one hundred fifty only) in addition to requisite examination fees of Rs. 500/-(Rupees Five hundred). The candidates those who shall not be able to submit examination fees and forms within 7th November, 2023 are liable to pay late fine of Rs. 150/- (rupees one hundred fifty only) as LATE FINE in addition to examination fees of Rs. 500/-(Rupees Five hundred only) on and from 8th November, 2023 to 11th November, 2023 on compliance of usual formalities as per previous notification.
