- 2) Post Publication Scrutiny (PPS) and Post Publication View (PPV) of answer scripts in one or more theory course(s)/paper(s) irrespective of marks obtained on submission of prescribed forms and fees of Rs.1000/-(rupees one thousand only ) per theory course/paper) within 22<sup>nd</sup> July,2026.

- (i) Candidates applying for Post Publication Review (PPR),are not eligible to apply for Post Publication Scrutiny(PPS)/Post Publication View (PPV) of answer script(s) of the same course(s)/paper(s),
- (ii) There shall be no scope of PP Review, PP Scrutiny and PP View of Internal assessment part/Viva voce/Term papers/Project works/Field report/Survey report and Practical Course(s)/Paper(s),if any,
- (iii) Application PROFORMA and details of rules in these regards may be available from the office of the Controller of Examinations of the University,
- (iv) PPS & PPV of answer scripts does not mean re-assessment/re-evaluation of answer scripts,

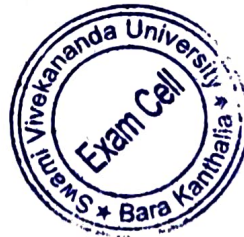
