3. OBJECTS OF THE TRUST:

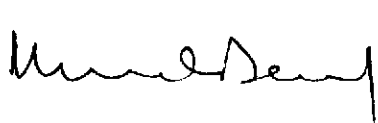

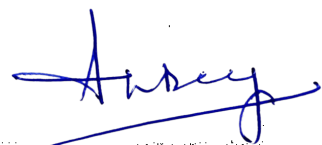

- b) To found, establish or takeover and/or otherwise conduct research institutions in all discipline of science, engineering, management, information technology, vocational training, primary and secondary schools, nursing school, medical college, dental college and surgical knowledge, and various allied fields of research and education.
- c) To provide medical relief to the Public in all branches of medical sciences by all available means.
- d) To provide research facilities for carrying on research basis and applied, in all systems and discipline of science and technology, keeping in view socio-economic need of the afflicted community.
- e) To conduct and to carry on experiment and to provide funds for research works and for scholarship, stipends, remuneration and or other payments or aid to any person or persons engaged in research works or works connected with or conclusive to research and to encourage and to improve knowledge of the persons who are engaged or likely to be engaged in any technical profession so as to benefit the Public at large.
- f) To establish and maintain or aid or support or help the establishment or maintenance of premises, centers, auditoriums, wells, tanks, roads and the like for the rendering of services to the general public;
- g) To establish and maintain, or support or help or aid in the establishment or maintenance of building premises, homes, hostels and the like for the benefits of students, faculty and staff;
- h) To establish, support, maintain and/or assist financially schools, college, gymnasiums centers, libraries, vocational institutions for the advancement of education and diffusions of knowledge in arts, sciences, literatures, humanities and all other useful subjects in all their manifestations;
- i) To grant scholarship, stipends, prizes rewards allowances and other financial assistance to students;
- j) To provide for integrated training of teachers, supporting staff and professional personnel ;
- k) To establish and maintain or aid or support or help by monetary gifts or otherwise, play grounds, public parks sports and games and other social welfare works;
- l) To establish and maintain or aid, assist or help in the establishments and maintenance of orphanage or other establishments for relief and or help to poor, old and infirm people and or restitutes;
- m) To provide help and assistance in cash or kind for marriage of poor girls, widows, orphan and/or poor and destitute people;
- n) To provide food, clothes, medicines and other help and/or assistance in any shape or form to the poor persons irrespective of caste, creed and religion.
- o) To carry out medical and dental Research by engaging in the research and development of all fields of medical science, and in all therapies of medical treatment, so as to afford medical relief in a better way.
- p) To give monetary and/or other help for the relief on occasion of natural and other calamities such as flood, famine, cyclone, earthquake, epidemic, storm, accidents to give donations subscriptions or contributions to institutions, establishments or persons doing relief work on such occasions;









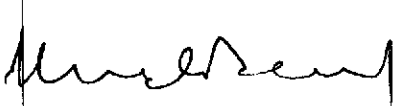
- q) To do all such acts and things as may be conducive to the attainment or furtherance of all or any of the objects of the Trusts subject to the restriction contained in clause 3.3 hereunder written.
- (3.4) It is expressly declared that Trustees are not authorized to do a work which is not of Public Charitable nature and no part of the trust properties or its income shall be applied for any purpose and nothing herein shall be construed to authorize the Trustees to utilize the Trust assets or its income where by it will forfeit exemption under the income tax or wealth tax Act. All the powers and provisions hereof shall be construed as being subject to and restrictions and limitation herein contained.

4. **DONORS AND DONATIONS**

- (4.1) The trustees may accept from time to time from any persons, firm or any other association of persons, trusts or institutions or societies and/or bodies corporate or incorporate, governments, local authority, universities or any other body, donation, subscriptions, moneys things, properties, moveable, gifts, sponsorship money upon such terms and conditions as may agreed upon between them and the donor or donors and as may be considered advisable and expedient by the trustees but always consistent with the objects of the trusts and limited to the trust or these presents and the trustees shall hold the same upon such terms and conditions as may as have agreed upon and utilize the corpus or income thereof in such manner and proportions in the fulfillment of the object or objects of the trust if necessary to execute such writings or instruments in respect thereof as they may from time to time approve of and direct in respect of the said donations, subscription, etc and for the purpose of collections of such donations formulate a scheme or schemes including installations of boxes and devise and adopt such other means as they may think fit and proper from time to time.
- (4.2) It shall be discretionary for the trustees to refuse any donations, contribution and/or offer of help assistance gift etc without assigning any reason from any person.
- (4.3) The Trustees, if they think fit and proper and for the benefit of the trust, may accept Loan, Secured or unsecured from Banks, Financial Institutions, Trustees or from any other private sources for specific purpose and the amount so raised shall be utilized only for the said purposes

5. **COMPOSITION OF THE BOARD OF TRUSTEES, APPOINTMENT OF OFFICE BEARERS, COMMITTEES ETC.**

- (5.1) The Trustees shall be collectively called **Board of Trustees**; the strength of the Board of Trustees shall be not less than **Two** and not more than **Eleven**. New trustees could be inducted by the unanimous consent of the then exiting trustees.
- (5.2) Upon the appointment of a new trustee the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees, with the duties and power of the trustees set out hereinabove in this deed.
- (5.3) The Trustees may appoint one amongst them to be the **Chairman** and shall appoint one to be **Secretary** or **Managing Trustee** and one **Treasurer** of the Board of Trustees. The Chairman of the Trust shall be X and the Secretary of the Trust shall X.
- (5.4) To conduct regular activities of the Trust, the Board shall take **decision by a majority** of votes and in the case of equality of votes the Chairman shall have the casting vote.
- (5.5) The Board of Trustees may as and when necessary and from time to time appoint committee or committees of Trustees and others for such powers and functions as to the board may appear fit, proper and appropriate.
- (5.6) A Trustee shall be disqualified from continuing as a trustees or shall cease to be a







trustee on the happening of any of the following events :

Death;

Physical or mental infirmity;

Resignation;

On being rendered incapable to perform the duties of a trustee

On being convicted in a court of law of any offence involving moral turpitude

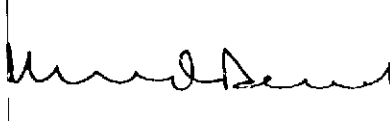
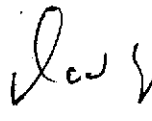
On failure to attend four consecutive meetings of the board of trustees without leave of absence;

On being adjudged insolvent.

- (5.7) If at any time the number of Trustees should fall below Two, the continuing Trustees must fill the vacancy which they are authorized to fill before transacting any other business but all acts, matters and deeds done and/or performed by the continuing trustees during the periods of the vacancy or vacancies shall be deemed valid if they are otherwise in accordance with these presents.
- (5.8) On the appointment of a Trustee to fill a vacancy or vacancies the Trust property shall stand transferred and/or become vested in the newly appointed Trustee or Trustees as well with powers of these presents to act as fully and sufficiently as if the new trustee or trustees had hereby been constituted as a trustee or trustees.
- (5.9) The trustees shall hold meetings of the Board of trustees from time to time as may be necessary but shall hold at least four meetings in a year. The quorum for a meeting of the Board of Trustees shall be 1/3 of its total strength of the trust but not less than Two Trustees. The Board may frame rules and regulations for the conduct of its meeting.
- (5.10) The trustees shall, keep or cause to be kept a minute book of their proceedings.
- (5.11) Every Trustee will be at liberty to resign by giving one month's notice of his intention so to do and shall be entitled to appoint any eligible person to act as the trustee in its place.
- (5.12) A meeting of the Board of Trustees shall be convened as and when required, or at the instance of the Chairman or Secretary, or on the requisition in writing of any three Trustees setting out clearly the subject or subjects for which the requisitioned meeting is sought within fifteen days of receipt of such requisition.

## **6. POWERS AND FUNCTIONS OF THE TRUSTEES :**

- (6.1) The board of Trustees shall have all powers appropriate and necessary for the fulfillment of any or all of the objects of the Trust or necessary and appropriate for the effective and efficient administration of the trust matters and affairs. Without affecting the generality of such powers and functions, the Board of Trustees shall have the following powers and perform the following functions:
1. To accept donations, contributions, grants, subscriptions or any aid or assistance or help in cash or in kind from any person.
  2. To apply the whole or any part of the income or accumulation thereof or the whole or any part of the corpus of the Trust property or fund for one or more of the objects of the trust as the Board of Trustees may determine from time to time ;
  3. To control, manage, superintend all the activities of the Trust and the Income properties and functions of the Trust;
  4. To invest and keep invested the Trust fund in such part thereof as is not immediately required to be spent in the manner hereinafter provided;
  5. To purchase, acquire or to sell, dispose of, alienate or otherwise deal with any property, moveable or immovable, comprising the Trust fund and to delegate any Trustee for such purpose;





6. To let out or demise any immoveable property comprised in the Trust fund for the time being for such period, and on such terms and conditions as the Board of Trustees or any committee thereof in this behalf shall think fit and proper for the benefit of the Trust.
7. To frame rules and regulations including fee structures, authorizing any one or more Trustees to look after finance and day to day administration & activities.
8. To open an account or accounts with any bank or banks, to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution one or more of the trustees jointly or such trustees jointly with an agent appointed by the board of trustees in this behalf to operate such account or accounts.
9. To arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to signed or executed on behalf of the Trust by any of the trustees to be nominated in this behalf by the board of trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all Trustees;
10. To adjust, settle, compromise, compound, refer to arbitration actions, suits, claims, disputes, differences and proceeding regarding the properties and affairs of the Trust;
11. To appoint constituted attorneys or agents or servants, to delegate to such attorneys or agents or servants, all or any of the powers vesting in the trustees under these presents and from time to time remove such attorneys or agents or servants and to appoint another or other in their place and to fix their duties, responsibilities and the terms and conditions of their employment.
12. To appoint or make provisions for the appointment of a sub-committee or sub-committees of Trustees and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the trustees may prescribe;
13. To authorise any of the trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions; rules and regulations as the Board of trustees may from time to time think fit and proper;
14. To make, alter, amend or modify or repeal schemes, rules and regulations, bye laws etc. for carrying out the objects of the trust and for the management of the affairs there of and for running any institution, academy, in furtherance of the objects of the trust or giving effect to the objects of the trust;
15. To set apart the whole or a part of that income or corpus or part thereof for any of the objects of the trust;
16. To spend any portions of the corpus or the income of the trust fund for purchasing any land and/or constructing any building or buildings for and in the name of the trust for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust;
17. To invest the moneys belonging to the trust including the reserve fund if any and/or any additions or accretions to the trust fund and/or any funds not immediately required for the purposes of the trust and/or all surplus moneys in such form or mode, in such manner and for such periods as prescribed and or allowed from time to time under the provision of the Income Tax Act;
18. To settle out of court or compound suits actions and other proceedings and all differences and demands and to refer any or all of such differences or demand to arbitration and to adjust settle and approve all accounts relating to trust fund or trust properties and to execute and/or do all other acts and thing relating thereto as if they were absolutely entitled to the trust funds or trust properties and without being answerable for any loss or losses occasioned thereby;

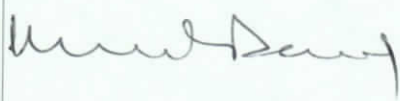

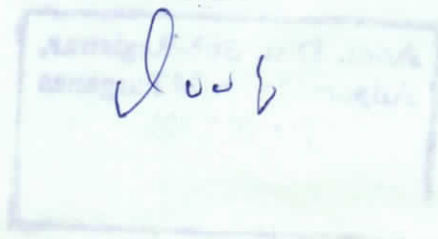

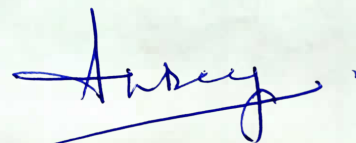
19. To take all steps necessary for the preservation and safety of the trust fund and trust properties and effect such insurance in the trust properties as the trustees may think fit and proper;
20. To keep and maintain proper books of accounts in which shall be entered all items of income and expenditure of the trust and to get such accounts audited at the end of each year;
21. To demand realize and receive interest and other income of the trust from such persons who are liable to pay the same and to realize the same from public debt office;
22. To take on hire or rent any property to carry out the objects of the trust on such terms and conditions as the trustees may deem fit and proper.

7. **GENERAL PROVISIONS**

- 7.1 The receipt of a person authorized by the Board of trustees in this behalf for any moneys paid or any property transferred or delivered to the trustees or for the purchase moneys of any property authorized to be sold shall effectually discharge any person or persons so paying or transferring or delivering.
- 7.2 The Trustees shall not be entitled to receive any remuneration as trustees but may reimburse themselves of expenses actually incurred by them in connection with the work of the trust or their duties relating thereto.
- 7.3 The trustees shall be respectively chargeable only for such money, stocks, funds, securities and income/or any trust property as they respectively actually receive notwithstanding their signing any receipt therefore for the sake of conformity and shall be answerable, chargeable and accountable for their own acts, receipts, neglects, or defaults and not for those of each other, nor for those of any banker, broker agent or other person or persons in whose name or in whose hands the trust moneys or securities or properties may be placed nor for the insufficiency or deficiency of any stocks, funds, share or securities of any other property nor for the depreciation or involuntary loss unless the same shall happen by their willful default or neglect.
- 7.4 The financial year of the trust shall be April to March provided, however, the Board of Trustees shall be at liberty to change the same from time to time if they do deem fit and proper.
- 7.5 The Board of Trustees shall appoint each year a Chartered Accountant or a firm of chartered accountants for the audit and verification of the accounts and the trust fund/properties and shall get the said accounts audited and the trust fund/properties verified by the auditors so appointed. The Board shall also fix the remuneration of such auditors.
- 7.6 The main office of the trust shall be located for the time being at. There may also be branch offices of the trust anywhere in India. The place of main office and branch office may be changed and/or other offices may be opened or closed as per the decision of the trustees.
- 7.7 If the income from the trust property in a particular year is not fully utilized, the unutilized income subject to the applicable provisions of the Income Tax Act, 1961 shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the objects of the trust.
- 7.8 The Board of Trustees may from time to time frame rules or amend, modify, add to and delete such rules for conduct of the affairs of the Trust and for regulating the meetings of the Board of Trustees.
- 7.9 No trustee shall apply any portion of the trust fund/property or any income of the trust for his/her own use benefit either directly or indirectly.
- 7.10 All securities, investments, bonds, titles, deed etc relating to trust estate and not









immediately required by the trustees shall be kept at the main office of the Trust or in safe custody with the banker or bankers of the trust as the Trustees may deem fit.

- 7.11 The Trustees may, by a resolution, direct that any act, deed or thing required to be done or executed by them be done or executed by any one or more of them, and in such case any act or thing done or executed in pursuance of such resolution shall be as valid and effectual as if it had been done or executed by all the trustees. Such delegation of authority may be general or special.
- 7.12 A Resolution in writing circulated amongst all the trustees for the time being and signed affirmatively by two thirds of the trustees or number nearest thereto shall be valid as effectual as if it had been passed at a meeting of the Board of Trustees duly called and convened.
- 7.13 The Board of Trustees may, by a unanimous vote of all the trustees for the trustee proposed to be removed, remove any trustees permanent or otherwise from office after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust estate or trust affairs and after arriving at a definitive conclusion that for the reasons to be recorded in writing the continuances of the trustee proposed to be removed as trustees of these presents was undesirable keeping the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his conduct and/or the charges leveled against him for his removal and the decision of the Board Trustees in this behalf shall be final and binding and shall not be called in question anywhere.
- 7.14 The trust created by these presents is irrevocable.
- 7.15 The Board of trustees may by a unanimous vote of all trustees for the time being in a meeting specially called for the purpose decide to amalgamate this trust with another having public charitable objects similar to those mentioned in these presents on such terms and conditions as to the trustees may appear fit and proper.
- 7.16 The Board of trustees may by a unanimous vote of all trustees present may decide to dissolve the said trust and all the assets and properties remaining after paying the liabilities if any shall be transferred or donated to any existing trust carrying on the objects and activities similar to the said dissolved trust.
